- Tolerance for spending money on the website. Comments included: No problem as long
 as it gets us the site we need. Many hands can help with the website, District 20. Is
 BlueHost what we need? Find someone who can help for little or no cost. How much do
 we have in the bank? Members are willing to help if they understand the need. If we
 have the money the website is a great place to spend it as long as it is easily updated.
